AND WHEREAS, on sharing his idea with certain people, especially the members of the staff, old students and well wishers of educational institutions, promoted by him, he could find that there are affluent and large hearted people to co-operate with him, in making true his dream of helping such pupils of outstanding talents or financial backwardness in getting proper education,

AND WHEREAS, accordingly he has executed this Deed of Trust with the following terms and conditions:

NOW THIS DEED WITNESSETH: -

1. **Name of the Trust: -**

The Trust hereby established shall be styled as "FRANCIS ASSISI EDUCATIONAL TRUST"

2. **The Registered Office: -**

The Registered Office shall be at Ernakulam and presently shall function in the premises of the Assisi School, Chembumukku, Kochi. The Trustees with 75% vote can decide to shift the Registered Office to any other place in Ernakulam District if found essential.

3. **Trust Property: -**

In order to effectuate the above referred decision the Settler, has settled on himself the sum of Rs. 1,000/- (Rupees One Thousand Only) to hold the same together with all additions and accretions there to and all other properties that may be acquired out of the same or otherwise and may herein after be the subject matter of the Trust herein after expressed with powers and on the terms and conditions herein contained, concerning the same.

4. **Objects of the Trust: -**

The objects of the Trust are-

- a) To provide educational assistance to deserving students by making available fees, uniforms, books and other requisites and also by way of arranging scholarships, loans etc. especially for students from poor families.
- b) To conduct or partake in, or to assist to partake in, festivals, competitions etc. in the field of academic, cultural, sports, arts, games etc. and to institute awards or prize or trophies etc.
- c) To give vocational assistance, or proper guidance to the students with brilliancy or special talents, to develop or make use of the same.
- d) To encourage the teaching staff or conduct seminar and such other training classes for the teaching staff, or financially aid them to attend such occasions, or to institute awards and prizes etc. to bring out the best in them and to develop the same. So that they can guide the pupils in a better way.
- e) And in general to do all such other things and matters as are conducive to the furtherance of the objects of the Trust.

The objects herein above mentioned are independent of each other and the Board of Trustees may from time to time apply the funds of the Trust in carrying on all or any of the aforesaid objects of the Trust.

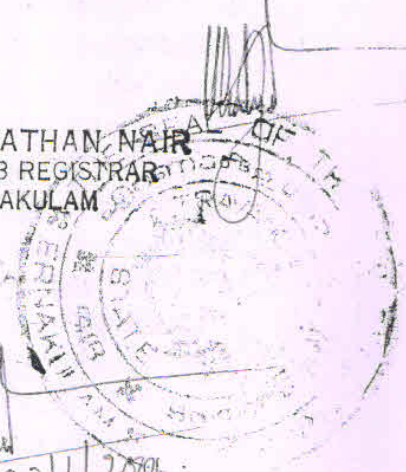
